### The Pandemic. The Promise. The Plan.

"For surely I know the plans I have for you, says the Lord, plans for your welfare and not for harm, to give you a future with hope." *Jeremiah 29:11 (NSRV)* 

### Rationale:

We have been impacted by global pandemics: Health, Economic and Racial Justice. The world has changed. We have changed. We have changed. We may never be the same again.

Some things will return and some may not. God will replace other things or not. We. We can explore in what ways we can co-create with God a better future.

"As the post-quarantine era began, churches expanded their thinking and moved into new territories. We heard leaders asking the right question: How do we move forward most effectively in these uncharted waters? Though they could see the potential mission field of the digital world, most admitted they were not certain how best to reach people and minister to them in this new context. Their questions were not simply about navigating unfamiliar technologies, but about how best to move forward on all fronts. This new era will likely include some blending and balancing between digital and in-person ministry."

### **The Pandemic:**

On April 10, 1816, the Reverend Richard Allen was installed as the Presiding Bishop of the African Methodist Episcopal Church. Undoubtedly, The Right Reverend Richard Allen brought an impressive resume of innovative and forward-thinking leadership, which is critical for this appointment. Bishop Allen's leadership during the Yellow Fever Pandemic of 1793 in Philadelphia and the resultant deformation of his name and African race would propel the new church to worldwide visibility and leadership. The then Reverend Allen did not cower to public opinion and falsehoods – but, rather, proactively and immediately responded in an unheard-of manner for Blacks at that time – by writing and publishing -- a publicly distributed pamphlet refuting accusations of such erroneous wrong-doing and bringing to light the subjects of racism and slavery.

This leadership remains today. The AME Church has been a vocal leader during the COVID pandemic – engaging worldwide renowned physicians and epidemiologists for accurate, up-to-date information for members and the world at large; providing research and studies on underserved global populations, and partnering with national and international health institutions to create walk-in testing and vaccination clinics; and promoting the world-wide distribution of critical information from the AME International Health Commission on an international level.

### The Promise:

Jeremiah 29:11 reminds us that as we experience the pandemic's long-term social, political, and economic effects, God has a plan for us to prosper and hope for our future. The verse also reminds us not to believe in things that are too good to be true and instead trust God and His process. For it is only in His process that we can be assured of hope for the future.

### The Plan

The African Methodist Episcopal Church is fervently planning for the "post-Pandemic church." The Church will engage visionary experts, church leaders, and lay to formulate the **plan** that will indeed address societal, technological, health, political, and economic changes – many of which have already left their footprint – while others continue to develop and expand as we speak. We can trust that the African Methodist Episcopal Church has the **key** to opening this visionary and masterful plan to the entire world, as we seek to explore this new, exciting season of opportunity.

Re: General Conference Commission Finance Committee

Under the guidance of the Chief Financial Officer (CFO), the Finance Committee of the General Conference Commission is tasked with the responsibilities of providing financial oversight for the General Conference to include:

- Oversees financial responsibilities and approval process
- Determines the overall budget
- Monitors Cash Flow
- Records income and expenses
- Creates ongoing financial reports and updates
- Compiles final report

The Chair met with the CFO and working finance staff team members for an initial review of the status of planning for the General Conference. As of the time of this meeting we are in the process of developing the budget as follows:

- Gathering information from prospective vendors in order to establish meeting expenses
- Identifying anticipated staffing needs and costs
- Identifying other meeting related expenses
- Working with accounting to determine adequate registration rates and timelines
- Working to reduce operating costs and find ways to ensure positive financial outcomes for participants and the church.

The General Conference Finance Committee Chair and members will work to support the office of the CFO in General Conference planning by assisting in ongoing and careful analysis of expenses. We will provide ongoing financial reports as required above.
