Bishop Paul L.M. Kawimbe, President

Convened at Atlanta, GA June 28. 2022

Mr. President, Bishop Paul L. M. Kawimbe, to the Bishops of the Church, General Officers, Connectional Officers, and the membership of the General Board of the AME Church;

The Nominating Committee of the General Board, subsequent to the last meeting of the General Board, was assembled, at the call of Chairman J Edgar Boyd, in a series of virtual meetings to continue its work in response to the mandate of the General Board, to staff out the General Boards "Commission on Financial Management Program."

The Nominating Committee was assembled last evening, June 27, 2022, at the call of the chair, to finalize its report to this session of the General Board. During its meeting, last evening, Bishop Kawimbe, President of the General Board appeared and was received by Chairman Boyd and the members of the committee. Bishop Kawimbe related to the committee that the Council of Bishops, in consideration of the impact of the purpose and work of the Commission on Financial Management Program, had met and was concerned as to how the commission might most effectively be implemented for the good of the denomination.

After his comments on the matter, Board President, Bishop Kawimbe, on behalf of the Council of Bishop, recommended that the Nominating Committee consider deferring the matter of the implementation of the commission to the AMEC's 2023 Legislative CONVO. Several questions and comments ensued and Bishop Kawimbe responded to each of the quarries.

Following the departure of Bishop Kawimbe from the meeting, Chairman Boyd offered brief comments and placed the recommendation of Bishop Kawimbe, and the Council of Bishops, before the body of the nominating committee. Dr. David Green moved that the "Recommendation," coming from the Council of Bishops be received and adhered to; Rev. Michael Ephriam seconded the motion, and the motion passed without objection.

By common consent, the nominating committee agreed to continue its work and efforts to refine a process as to how the "Commission Financial Management Program" can best be placed within the bodywork of the AMEC's 2023 Legislative CONVO which will be convening in a few months.

The second item on the agenda of the Nominating Committee was the nomination of Episcopal Leadership for the second half of the 2020/2024 interim General Board. The following is the recommendation from the Nominating Committee:
