On Tuesday, June 28, 2022 the Department of Retirement Services Commission met in Room 706. Greetings were offered by Dr. James Miller, Executive Director; Bishop Marvin Zanders, II, Co-Chair; and Bishop John F. White, Sr., Chair.

Sharing in the meeting were Bishops Michael Mitchell and Wilford Messiah; CFO, Mr. Marcus Henderson, Attorney Douglas Selby, Litigator Wendell Taylor, the members of the Commission, and observers.

Bishop John White, Sr. Commission Chair, stated that it's a New Order and a New Day, the Commission and the Department has been called to be innovative and creative in serving the kingdom of God through the AME Church.

Dr. James Miller, Executive Director shared his report covering the Business, Properties, and Goals of the Department, along with the Legacy, New Life, Stewardship, Financial Statements, Fiduciary Responsibilities, and Commission Organization. The report was received as information.

A Cautionary Note

Dr. James Miller began his report by stating that the African Methodist Episcopal Church and the Department of Retirement Services have been victims of a gross and egregious criminal act which is being investigated. All plan participants' balances have been reduced to approximately 30% of their June 30, 2021 balances. The AME Church is earnestly pursuing a plan of restoration. Although this report will detail the present condition of the Department of Retirement Services, it will not contain information that will impede the audits and legal investigations which are ongoing.

This report will not go into the who, what, when, where, how and why of the investigation. However, it will provide a clear picture of the current fiscal and operational landscape of the Department of Retirement Services, and;

- 1. Reveal our balances ending with the Department of Retirement Services fiscal year;
- 2. Address our ability to execute our growth strategy;
- 3. Present our technological challenges;
- 4. Report on capital losses incurred;
- 5. Indicate the need for new General Conference legislation and additional changes in policy;
- 6. Present a detailed timeline of the work of the Commission since the December 2021 General Board Meeting held in Nashville, Tennessee;
- 7. And finally, present recommendations for the deliberation of the General Board.



Current Technological Challenges

The commission is working with the Department of Retirement Services to upgrade the technology needs for the department to reduce the delays of the antiquated system, to expedite current transactions, as well as accommodate the systems associated with the New Life Plan by the fall of 2022.

During the January 31, 2022 General Board Meeting, the General Board approved the Commission on Retirement Services' recommendation to unfreeze the accounts as of March 1, 2022.

Since that time distributions have been made. The process of distribution was taken from the earliest requests dating back to June 2021. The categories are hardships, annuit deaths, full surrender retirements and required minimum disbursements.

Building Back Better

We understand that trust has been broken. The following recommendations are what we are doing to rebuild that trust.



1. The forensic auditor recommends the African Methodist Episcopal Church take appropriate legal action against the perpetrators of this conspiracy, based on the advice of AMEC legal counsel.

Progress:

The Commission and the General Board have been updated by Attorney Selby on the legal proceedings.

2. The forensic auditor recommends that a detailed internal control review be conducted of the Department of Retirement Services that will address weaknesses that allowed for the matters noted in our report to happen and go undetected.

Progress:

The Commission after vetting several firms has secured the services of Hoskins & Associates to perform an audit. Results are expected in the fall of 2022.

3. The forensic auditor recommends that a comprehensive review be performed of the sections of The Doctrine and Discipline of the African Methodist Episcopal Church that govern the Department of Retirement Services as it relates to governance and oversight.

Progress:

The Commission has tasked the oversight committee to address this recommendation.

4. The forensic auditor recommends that the Department of Retirement Services conducts a separate annual audit of the retirement plan assets. Furthermore, the audit results be communicated directly to the Commission by the auditors.

Progress:

The Commission has developed and implemented an Audit Procedure Plan for a working effective Agreed Upon Procedures (AUP) for the Department to act in accordance.

Status Updates from the Commission

The General Board requested that The Department of Retirement Services and its commission will identify, engage, and establish a new annuity program with one of the Top 10 403B provider companies that will provide for direct payments from churches and management of his/her investment account by June 8, 2022.

Progress:

After systemically evaluating nine proposals the Commission recommended and the General Board approved the selection of Wespath Benefits and Investments. Documents have been executed by Wespath and AME Inc that will allow the New Life Plan to become accessible by all participants by fall of 2022.

Status Updates from the Commission

- The Commission hired an actuarial firm. Upon its completion of the final report, it will be submitted to the Statistics and Finance Commission.
- The Commission completed the planning grant from the Lily Endowment.

Goals of the Department of Retirement Services

- 1. Execute a secure transfer of the plan participant funds from Symetra Life Insurance to the New Life Plan.
- Establish the first formal Stewardship Department of any Black faith group or denomination, as a component within the Department of Retirement Services.

Final Recommendations

- We recommend to the General Board to require each Episcopal District two district representatives to work with Wespath in the transition to the New Life Plan. Representatives will input data, will gather participants data, and will be trained by Wespath.
- The Department of Retirement Services recommends that each episcopal district, will instruct every plan participant complete a new participant profile to have accurate information for the New Life Plan Database by July 15, 2022. The link will be provided through the CIO Office, Episcopal District and Presiding Elders, along with the Department of Retirement Services website.

Final Recommendations

 That the General Board encourages all members of the entire African Methodist Episcopal Church to seek God in prayer for the Department of Retirement Services.
